Area to include

Appendices provide additional detail for readers with specialised interests. Any supplementary materials that need to be included, but which are not crucial to the understanding of the audit should be incorporated into this section. Typical appendix items would be:

1. Detailed tables, charts and statistical analyses.
2. Copies of instruments and documents used.
3. Glossary of terms including acronyms.

Appendices should be placed in a separate volume if they are likely to make the report appear off-puttingly large.
